





WHAT THE COMPANY MOVING BOX SRL HAS MADE TO IMPROVE THE ADMINISTRATION OF THE GENERAL ARCHIVE OF THE MILAN TRIAL COURT.

MOVING BOX SRL started almost a year ago to study how to innovate the the administration of a public studio such as the Milan trial court is. Our existing mobile shelving system was outdated and no founds were available to replace them. The company MOVING BOX SRL presented us a project that allowed us to continue using the existing structures and to put on them a new technology low cost but innovative, which is able to automate our equipment.

A low cost field testing has been created by exploiting **for free** the existing shelving equipment and putting on them an automatism called **PLUG & MOVE**.

PLUG & MOVE answered completely to our need because it made possible to modernise the system with limited financial resources and to recover the existing structures.

PLUG & MOVE permitted:

- 1. Mapping the archive.
- 2. Opening with personal password.
- 3. Tracking down files with a tag.
- 4. Handling automatically recorder books.
- 5. Memorising files stocked in the archive or in other offices.
- 6. Memorising and authorising operators in the archive.
- 7. Checking all the activities.

The advantages deriving from its use are very important:

- 1. Low cost services of installation and maintenance.
- 2. Operator safety.
- 3. Low cost automation.

We are extremely satisfied of the supply that the company MOVING BOX gave us. In my whole carrier in this archive, which lasts 30 years, no other company gave us so much professionalism, human resources and high technology such as this company. 
